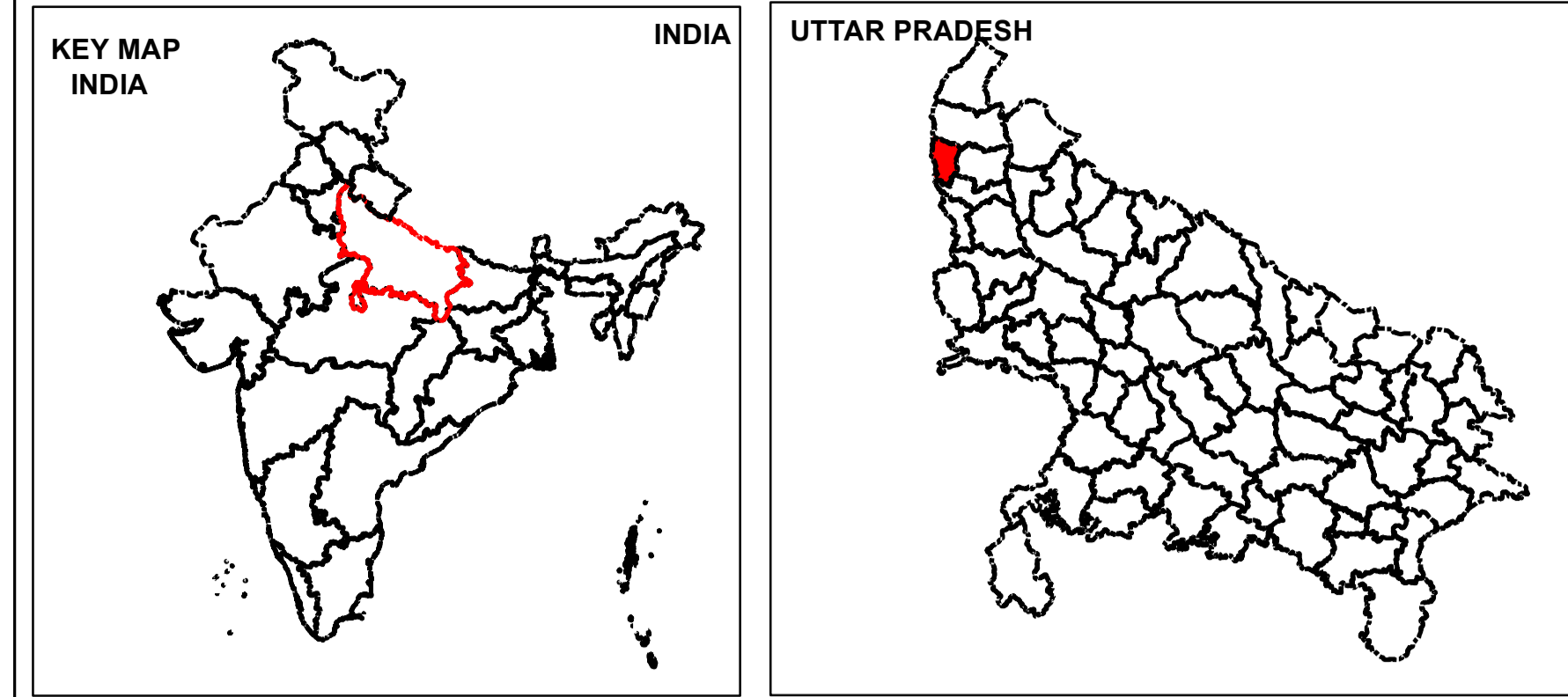


GIS BASED MASTER PLAN 2031 (DRAFT) "BAGHPAT BARAUT KHEKRA"

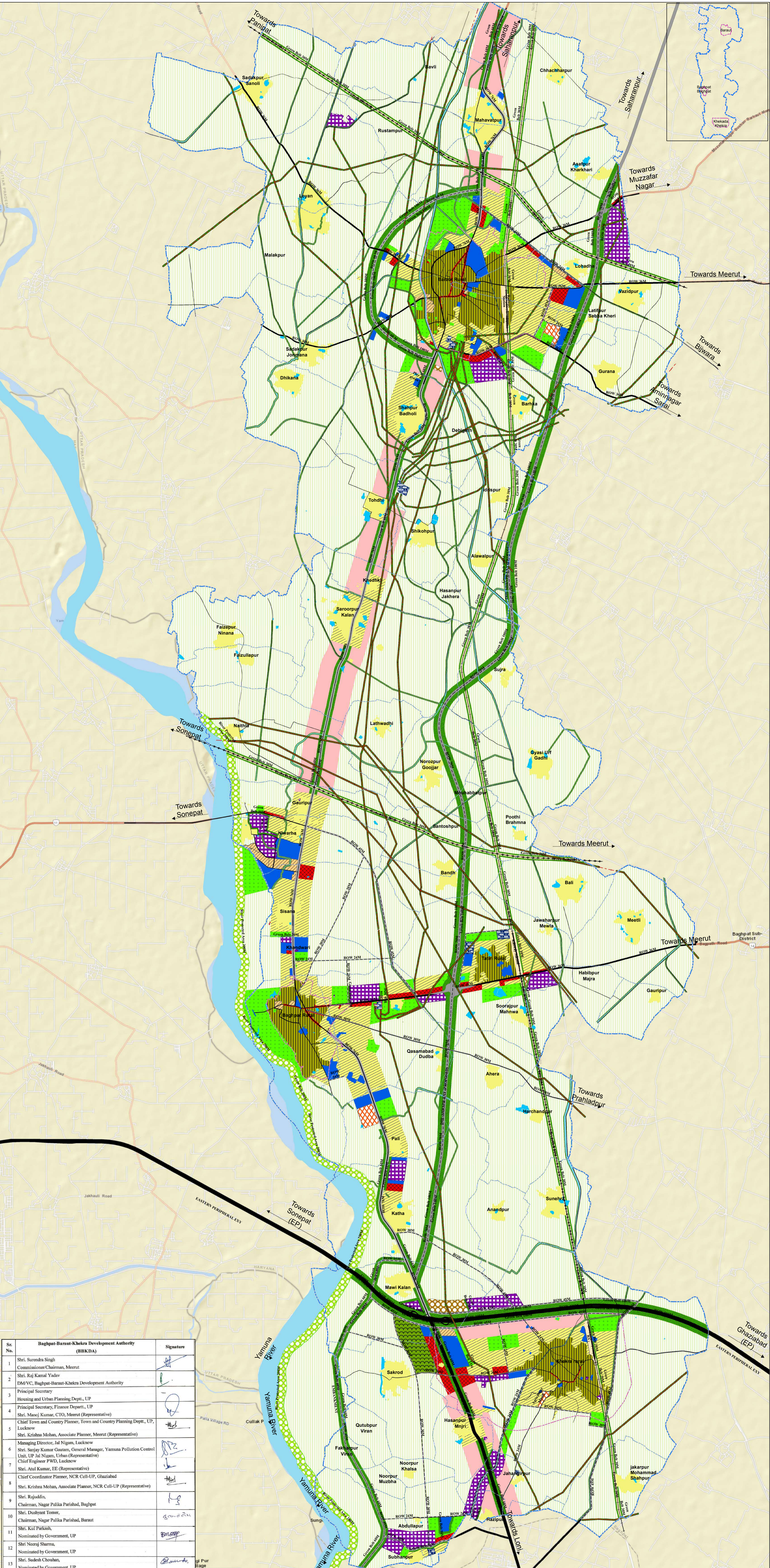
